The Rector of the Slovak University of Technology in Bratislava (hereinafter referred to as "STU") in accordance with Article 5 (1) of the Rector's Directive No. 6/2015-SR Rules for awarding the Slovak University of Technology in Bratislava Rector's Prize is issuing the following

Amendment No. 1

to the Rector's Directive No. 6/2015-SR of May 19, 2015

Rules for awarding the Slovak University of Technology in Bratislava Rector's Prize
(hereinafter referred to as "Amendment No.1")

Article I.

The Rector's Directive No. 6/2015-SR of May 19, 2015 "Rules for awarding the Slovak University of Technology in Bratislava Rector's Prize" (hereinafter referred to as the "Rector's Directive") shall be amended and supplemented as follows:

1. In Article 2 Clause 1 of Rector's Directive the words "where more than 25 graduates have completed their studies," shall be erased.
2. In Article 2 Clause 2 of Rector's Directive the words "where more than 25 graduates have completed their studies," shall be erased.
3. In Article 2 Clause 5 after the words „Rector's Prize“ a word „best“ shall be inserted and the words „when, as a student, a written application is submitted for permission of his/her Dissertation Thesis Defence³ during the standard term of study and where“ shall be erased.
4. In Annex to the Rector's Directive in the sample form Basis for awarding the Slovak University of Technology in Bratislava Rector's Prize to graduates of a doctoral program a table row "Submission date of the written application for permission of Dissertation Thesis Defence [Art. 2 (5) of the Directive]:" shall be erased.

Article II.

1. Other provisions of the Rector's Directive shall remain unchanged.
2. Amendment No. 1 shall form an inseparable part of the Rector's Directive.
3. Annex No. 1 containing "The complete wording of the Rector's Directive No. 6/2015-SR of May 19, 2015 - Rules for awarding the Slovak University of Technology in Bratislava Rector's Prize - as amended by Amendment No. 1 of September 26, 2016" shall form an inseparable part of Amendment No. 1 to the Rector's Directive.
4. Amendment No. 1 shall become valid and effective on the date it is issued.
